Communication to homeowners with local HPC designation

Town Liaison Report - Karen Jenkins

 The splash park was completed and has been temporarily shut down because the wrong sealant was used which made the park too slippery and dangerous.

- A wonderful dedication ceremony was held for the memorial and the park with a beautiful sculpture by Mary Taylor.
- A final board vote was taken to disallow short term rentals (like AirBNB) in Mendon, unless they are owner-occupied(like a bed and breakfast).

Town Historian Report – Diane Ham

- Work is ongoing on a book about the history of Mendon Ponds Park being written by Diane Ham and a co-author.
- There used to be a dozen farms around the ponds and two old roads no longer used.

Report on the Landmark Society Preservation Conference in April, by Martha Bush

1. Best practices of other HPCs include:

- Many towns and cities use database software to keep track of all the
 properties in their area. Managed by the code enforcement department,
 this software holds not only property specs, permit history, tax history, and
 assessment history, but also whether the property is designated by the
 National Register or a local HPC. Having the list of historic properties in
 an easy-to-access digital format saves the code enforcement team
 considerable time and effort.
- Many HPCs require that one of the commissioners be a realtor.
- HPCs are trying to include an architect and representation from minority communities

2 Legislation

- HTC-GO new Historic Tax credits legislation introduced in House and Senate and expected to pass. Increases value of historic tax credits that have been degraded due to a combination of inflation, increased interest rates and adverse IRS rulings.
- National Trust for Historic Preservation has a new website with state-by-state data and resources.

- Erie Canal Bicentennial 2025
 - A package of promotional material to be available to communities along the canal.

4. Other Resources for Historic Preservation

- William G. Pomeroy Foundation for historical markers. National organization based in Syracuse. They produce NO cost historical markers through their own fundraising. They help edit the copy to ensure that they are fully representative. We apply for markers and they create them, then we must install them.
