New Business:

1. Mitten Subdivision

- Members discussed their concerns for the subdivision via email prior to the meeting so that comments could be prepared for the next board meeting

2. SEQR Form discussion

- When applications go before the Planning Board with a SEQR form (State Environmental Quality Review), there is a trigger (question #12 about a National and State Historic Preservation designation) for the Planning Board to engage the HPC in the review of the application. Currently, this form does not mention a local designation.
- A question was raised about why the form is missing a question about local historic preservation designation.
- M. Bush agreed to reach out to NY SHPO to ask about this.

Old Business:

1. Barben's property – 983 West Bloomfield Rd

- A new C of A application was received about replacing windows on an attached porch to the property. The current windows were not original to the home and do not represent historically accurate windows, but they were there when the home was designated, so they are grandfathered in.
- The new application to replace these windows with sliding windows would also not be historically accurate, but we can only recommend, not require changes that were not part of the original designation.
- The HPC moved to give conditional approval for the Barben's plan if they would provide drawings of their replacement plan. We also will suggest they consider replacing the windows with Double-hung windows



with muntins, or simulated grilles to make them look more accurate to the home.
